रेशन दुकानांची तपासणी; गुलदस्त्यात अहवाल

सोलापूर, दि. ३० (हिंदुस्थान समाचार) : शहरातील रास्तर भाव दुकान क्रमांक ६९ ब व ४६ ब या दोन दुकानांना जात असलेले शासकीय धान्याचे वाहन पोलिसांनी संशयावरून पकडले होते. पण प्रभारी जिल्हा पुरवठा अधिकारी यांच्या सूचनेनुसार संबंधित वाहन सोडून देण्यात आले.

पुरवठा विभागातील अधिकाऱ्यांनी संबंधित दुकानातील धान्य वाटपाची चौकशी केली. चौकशीमध्ये काही फिटल धान्याची तफावत आढळून आल्याचे कळते. पण अद्याप तपासणीचा अहवालच वरिष्ठ कार्यालयास सादर केला नाही. प्रभारी जिल्हा पुरवठा अधिकारी अनिल कारडे यांनी मला याबद्दल

माहिती नाही. माहिती घेऊन सांगतो, अशी माहिती दिली. काळ्या बाजारात जात असलेले धान्य पोलिसांनी परमिटवरील खाडाखोड केल्याच्या संशयावरून पकडले. पण पुरवठा विभागाने ते धान्य शासकीय असून, रेशन दुकानात वितरणासाठी पाठवण्यात असल्याचे सांगून

वाहन सोडवून घेतले. दुसरीकडे ब झोन म धील पुरवठा निरीक्षक व इतरांनी संबंधित दुकानाची तपासणी केली, तपासणीमध्ये दुकानांमध्ये धान्य वाटप व प्रत्यक्षात मिळालेले धान्यात तफावत आढळून आल्याचे कळते. पण त्याचा अहवालच अद्याप पुरवठा विभागास सादर करण्यात आला नाही.
